MEMBERS RESPONSIBILITIES

Members are fully responsible that they and their guest follow all posted signs, notices, directives, and Range Rules.

Members are fully responsible for the actions of their guests.

Members are fully responsible for their personal property and their guest's personal property and vehicles. In no case will Wild West Traders, LLC be responsible for the safety of or the damage to any member's or guest's property.

Members are fully responsible for anyone under 18-years of age. In no case will the children of any member or guest be allowed on the property without the adult member's or adult guest's supervision at all times.

Except normal wear and tear, any damage to any property is the member's responsibility to repair or replace at Wild West Traders, LLC discretion. It is also the member's responsibility to report any damage or destruction of any property.

Any range property loaned or rented to any member or their guest is the member's responsibility. The return, repair, or replacement of this property is the member's responsibility.

RIGHT OF REVOCATION & MEMBER BENIFITS

Any member, guest or person that fails to obey any safety rule, policy, sportsmanship rule, contest rule, training rule, or any other term of entrance is subject to suspension or revocation of their membership or range usage rights. There will be no refund of any monies, membership dues, fees, or deposits if any person is required to leave the property or if any membership is suspended or revoked for failing to obey any rule. Member benefits are subject to change at anytime and are retro-active to all existing memberships. Member benefits posted on the Wild West Traders, LLC web site wwtguns.com are considered current.

MEMBERSHIP TYPES & DUES

Single and Family Memberships are for one year. A Family Membership is defined as a married couple, or domestic partnership, plus children 18 or younger (all living in the same home). Single Half Year Membership does not include once a year \$25 off new gun purchase. Membership dues are due and payable in full on the annual anniversary of the member's membership. A 30-day grace period will be allowed for the payment of annual dues. After the grace period, the member reverts to the regular, non-member, range rates and forgoes any accrued benefits.
